# INTRODUCTION

Hosting the MONDIACULT 2025 conference in Barcelona offers an opportunity to encourage both institutional and public debate on key issues in the international discourse on culture and development, as well as on the policies that address them. Issues such as cultural rights, the impact of digital technologies on cultural practices, the status of artists and cultural professionals, cultural and linguistic diversity, the role of culture in global agendas, and the culture of peace, all central to the MONDIACULT programme, have a clear influence on the local cultural ecosystem, on citizens, and on local, regional, and national policies, and can be enriched through contributions from these multiple stakeholders.

Furthermore, hosting the UNESCO-promoted MONDIACULT 2025 intergovernmental conference recognises the role Barcelona has played and continues to play in the global debate on culture and development. Over recent decades, the city has demonstrated its capacity to contribute original and meaningful insights, emphasising the importance of context, connecting civil and official spheres, and linking culture and society... a capacity that can be highlighted at MONDIACULT and projected even more strongly in the coming years.

Given the importance of this framework, Catalonia's institutions (the Government of Catalonia, Barcelona City Council, and Barcelona Provincial Council) together with the Ministry of Culture have agreed to jointly promote Agora Cívica, a space for debate and the exchange of local and international experiences and reflections in which to collectively consider the role of culture in the construction of contemporary societies.

The MONDIACULT 2025 Agora Cívica seeks to establish links with the topics addressed at the intergovernmental conference. It will take place across several venues in Barcelona from 26 September to 1 October, aiming to contribute to the MONDIACULT debates, foster public discussion on agenda topics, and promote connections between local and international cultural stakeholders.

The Agora Cívica programme consists of activities defined by the organising institutions, alongside others proposed by local and international civil society (associations, networks, platforms, etc.), as well as by the curatorial team responsible for coordinating the activities.

The programme aims to connect local initiatives with international debates. In this context, Agora Cívica also collaborates with United Cities and Local Governments (UCLG), incorporating three sessions from its 6th Culture Summit and enabling local and regional governments from around the world to have a presence in Barcelona. In this way, Agora Cívica will also contribute to debates on the role of culture in building sustainable cities and in shaping a Post-2030 Agenda that includes a specific cultural goal, one of the central themes of the MONDIACULT 2025 programme.

The organisation of the Àgora Cívica has only been possible thanks to the contribution and involvement of many people, organisations and authorities. In addition to the many names included in this programme, the contribution of those who have participated in the design of activities, attention to participants and the other essential tasks of a programme of this size must be recognised. Likewise, we would like to thank in particular the collaboration of the venues where most activities will be held, including the Centre for Contemporary Culture in Barcelona (CCCB), the Barcelona Museum of Contemporary Art (MACBA), the Institut d'Estudis Catalans (IEC) and the Centre of Cultural Studies and Resources (CERC) at the Barcelona Provincial Council.

# PROGRAMME STRUCTURE


Thematically, Agora Cívica is organised around six key topics, which allow for the exploration of key issues on the international cultural agenda that are also relevant at local, Catalan, and national levels. Structuring the programme around these topics also provides guidance to participants when deciding which sessions to attend. Specifically, the following topics have been defined:

- A. Cultural rights: This topic aims to deepen the debate on the implications of cultural rights as a guiding framework for cultural practices and policies. It emphasises citizen participation in cultural life, addressing inequalities in the cultural sphere, the connections between culture and other areas of society (education, health and wellbeing, etc.), and the legal and policy frameworks that support the exercise of cultural rights.
- B. Cultural and linguistic diversity: This topic aims to reflect on the challenges of cultural and linguistic diversity and the actions of civil society and governments in this regard. It will address issues related to cultural identities and interactions, the promotion of the social use of language, and how technological and social practice changes affect the management of cultural and linguistic diversity, as well as the policies in place in these areas.
- C. Technologies and artificial intelligence: This topic will address the transformations that Artificial Intelligence and digitalisation bring to cultural life, particularly in areas such as creation, production, distribution, and access. It will also examine the resulting ethical, legal, and economic challenges, the implications for the organisation of cultural sectors, and the responses from public policies at local, national, and international levels, as well as from cultural actors.
- D. Culture and peace This topic recognises that, although conflict is an inherent element of human societies and is reflected in culture, culture also provides a necessary space for fostering encounters and building consensus. In a world marked by numerous conflicts, it will highlight experiences and reflections showing how culture can both reveal tensions and contribute to the construction of peace.
- E. Cities and the Culture Goal on global agendas This topic addresses the current debate regarding the inclusion of culture in global sustainable development agendas, particularly the proposal for a dedicated Culture Goal in the Post-2030 Sustainable Development Agenda. It will also showcase the commitment of many cities and regions to connect culture with sustainable development and to incorporate this link into local, national, and international strategies.
- F. Cultural ecosystems This topic focuses on the configuration of cultural sectors, including current transformations, innovation in organisational models, their economic dimension, and their networked structure. It will also consider policies affecting cultural sectors, from direct support to adapting legal and policy frameworks to recognise the specific nature of cultural organisations and practices, including the review of governance models.

The Agora Cívica programme includes a "main block" of activities as well as a set of complementary activities. The main block covers the six topics described above and is freely accessible to anyone accredited to attend Agora Cívica. Complementary activities, which are not associated with any specific topic, may in some cases have specific registration and access requirements, which are clearly indicated in the programme.

In parallel with Àgora Cívica, various institutions and organisations are also hosting activities related to the topics of MONDIACULT 2025, which are open to both the public and professional sectors. Many of these activities form part of Àgora en Xarxa (Àgora in a network) and are also included in this programme.

The opening lecture of the Àgora Cívica will place cultural rights as a paradigm for understanding culture as a key element in human development and sustainability. The role of the United Nations Special Rapporteur on Cultural Rights, held by Alexandra Xanthaki since 2021, has been fundamental in promoting a better understanding of the meaning of cultural rights and their translation into policies and practical applications worldwide. In this inaugural lecture, she will address, among other things, the relationship between the universal character of cultural rights and the recognition of the diversity of ways of life and expression.

Presentation of the Cultural Rights Plan developed by the Spanish Ministry of Culture, conceived as a strategy and guide to ensure that all people can fully participate in cultural life, access it, and transform it under conditions of equality. The plan includes 146 measures targeting five priority areas: ensuring cultural democracy, promoting culture as a tool to address contemporary challenges, fostering sustainability and independence of the cultural ecosystem, consolidating cultural rights as a framework for public action, and developing a public administration committed to safeguarding cultural rights and sensitive to their needs.

This session showcases the legislative work on cultural rights undertaken by various autonomous communities in recent years. It aims to share the processes, outcomes, and lessons learned from these experiences, such as the Public Culture System Law of the Canary Islands and the Regional Law on Cultural Rights of Navarra. Additionally, it will highlight ongoing initiatives in this field by other communities, including Catalonia, with the draft Cultural Rights Law currently under review, and the Basque Country, with the forthcoming law regulating the Cultural System of Euskadi.

The concept of cultural diversity has gained prominence in public policies, institutions, and discourses around coexistence, inclusion, and representation. However, what exactly do we mean by cultural diversity? To what extent are the frameworks and categories we use to define it valid or sufficient? What are the implications of continuing to reproduce this paradigm? This roundtable debate proposes a critical and open reflection on the limits, tensions, and possibilities of diversity as a category, and the urgency of moving towards broader and more complex concepts that do not merely sum "different" identities under a single framework, but allow us to rethink modes of recognition, participation, and coexistence from a genuinely inclusive, critical, and situated perspective.

From an interdisciplinary perspective, how do education and culture intertwine? How can education serve as a bridge and a tool for transmitting a diverse and expanded concept of culture? What capacity does it have to encourage participation in cultural life? What intersections exist between education, creation, and sustainability? If educating means preparing for an unknown future,



developing creativity can help us undertake projective and transformative work in the face of uncertainty. At the same time, the mobilisation of culture, art, and creative practices, sometimes with a subversive character, can challenge established certainties and habitual dynamics, opening space for freedom and social transformation, and fostering the development of active and aware citizenship.

In 2007, the Fribourg Declaration on Cultural Rights was presented, the result of extensive work carried out by the so-called "Fribourg Group" of the Interdisciplinary Institute of Ethics and Human Rights at the University of Fribourg, Switzerland. This text, of significant international importance, sought to consolidate rights already recognised in other instruments, highlighting both the cultural significance of cultural rights and the cultural dimensions of other human rights. Nearly 20 years later, many other initiatives have followed in its wake. This dialogue brings Patrice Meyer-Bisch, director of the aforementioned Fribourg Group, to reflect on the current state of cultural rights, taking a retrospective look at the work carried out and offering a forward-looking perspective on the challenges we face today.

Who has real access to culture? Who can work in this field? Which stories are told and which are left out? Drawing on her book "Culture Is Bad for You: Inequality in the Cultural and Creative Industries", Orian Brook will share key findings from her research, conducted alongside Dave O'Brien and Mark Taylor, on how exclusion operates within the contemporary cultural system, from who can afford to study or work in the arts, to how it is decided which cultural practices and expressions are deemed valuable. Bibiana Collado and Brigitte Vasallo will join in a dialogue on the role of writing as a tool for denunciation, memory, and transformation. Both authors have explored, through literature and critical thought, how class, gender, geography, and sexuality influence who can speak, which narratives are legitimised, and which are marginalised. Through reporting, poetry, essays, and activism, they have created work that challenges, provokes, and refuses to reproduce hegemonic narratives.

In the face of the increasingly evident ecosocial collapse, how important is the emergence of new protection paradigms such as biocultures or climate and ecosocial justice? How urgent is the promotion of alternative development models that unify culture and nature? As Yayo Herrero observes, "we are nature, and our lives are inevitably subject to the physical limits of the Earth", highlighting the importance of fostering collective cultural narratives that shift the Anthropocene paradigm and propose new ways of relating to biodiversity and non-human species. These narratives are already present in traditional ways of life and the knowledge they embody, and are increasingly reflected in a new wave of regulations and jurisprudence emerging in recent years in response to the devastating consequences of extractivist activities driving current trends.

Despite decades of advocacy and some progress, gender inequality remains deeply rooted in the cultural and creative sectors. UNESCO recognises gender equality as a fundamental human right and a cornerstone for inclusive and sustainable development. Advancing cultural rights requires transforming cultural policies through a gender perspective. This session will explore the persistent underrepresentation of women in key roles and areas, the barriers faced by women and gender-diverse individuals in accessing and participating in cultural life, and examine policies implemented to address these challenges.

It will explore how the cultural dimension intersects with and enriches all rights. The discussion will address bodies, care, ways of life and relationships with the territory, from a perspective that understands culture not as an isolated sector, but as an condition for a dignified life. An invitation to reflect together on how culture connects rights and opens pathways to imagine and build fairer futures.

# 12.00 - Deprogramming the world: open-air cinema for cultural rights

What does it mean to look at the world from other places, other bodies, other realities? It is a commitment to the audiovisual as a tool for political activation, collective memory, and cultural transformation.

One of the foundational myths of various Latin American countries has been the integration of their populations as "mixed-race" nations. In narratives from former colonial powers, the mixing of Indigenous and European peoples is celebrated as a positive consequence of colonisation, emphasising the outcomes of cultural and population mixing. Many national narratives similarly rest on a celebration of miscegenation, often recounted with pride. Which mechanisms construct these narratives? How does the mixing of cultures and populations become a political category? In this lecture, linguist, writer, and researcher Yásnaya Elena A. Gil, an advocate for linguistic and cultural diversity, reflects on the need to establish "processes of mixing" as a category distinct from "processes of miscegenation".

At a time marked by global uncertainty and social tensions, feminist perspectives are key to imagining fairer, more diverse, and viable futures. This activity offers a space for critical and constructive debate and also serves as the presentation of the new course at the Barcelona Humanities Institute, titled Overcoming Outdated Frameworks to Design Better Futures, directed by Christo Casas and scheduled at the CCCB in February 2026. From feminist and queer perspectives, this debate aims to be a starting point for reclaiming a cultural and political offensive, imagining desirable futures, building new alliances, and reaffirming culture as an essential space for rethinking key concepts such as diversity, justice, equity, and freedom.

# TECHNOLOGIES AND ARTIFICIAL INTELLIGENCE

This topic will address the transformations that Artificial Intelligence and digitalisation bring to cultural life, particularly in areas such as creation, production, distribution, and access. It will also examine the resulting ethical, legal, and economic challenges, the implications for the organisation of cultural sectors, and the responses from public policies at local, national, and international levels, as well as from cultural actors.

This roundtable aims to explore some of the urgent debates arising from the introduction of artificial intelligence into the cultural ecosystem. At its core is the impact on creative processes: between collaboration and extraction, Al challenges established notions of authorship, alters production conditions, and raises new conflicts around usage rights. The session will also discuss how these technologies reconfigure symbolic circulation and reinforce asymmetries in a platform-dominated ecosystem, questioning not only creation but also the traceability and ways in which archives, memories, and therefore cultural heritage are constructed, defined, and accessed.

12.15 - Who controls technology? Algorithms and sovereignty: a political genealogy of artificial intelligence

In a present increasingly mediated by automated systems, approaching AI from a cultural perspective is key to activating critical imaginaries and opening up the possibility of fairer, more shared futures.

The development of artificial intelligence poses significant ethical, social, and environmental challenges, particularly regarding the reproduction of structural biases —sexist, racist, ableist— and the invisibility of the human labour that underpins AI systems. This debate will examine the need for effective oversight, more transparent and auditable models, and accountability frameworks for those implementing AI. From multiple perspectives —from data architecture to digital justice in global contexts— the session will also explore the ecological costs of large-scale model training and the urgent need to imagine sustainable, decentralised, and culturally diverse technological infrastructures.





The project Promoting culture, transforming the world offers a shared reflection on cultural rights and sustainability, initiated by the Catalonia 2030 Alliance. The project is part of the global call by numerous organisations —including UNESCO— to recognise the role of culture in sustainable global development. In this regard, since the UN's adoption of the 2030 Agenda and its 17 Sustainable Development Goals, many institutions have advocated for the inclusion of an 18th SDG focused on culture. In Catalonia, there are various initiatives and spaces for reflection and action in this area. One of them is the Catalonia 2030 Alliance, a coalition of public and private actors created in 2020 by mandate of the Parliament of Catalonia, aimed at working collaboratively to achieve the SDGs. Coordinated by the Advisory Council for Sustainable Development (CADS), as of June 2025 the alliance comprises nearly 90 organisations and, since early 2025, includes a working group on Culture and Sustainability.
